In order to support national humanitarian efforts, we have launched the Emergency Fund for Ukraine, for organizations active in Făgăraș Country and beyond.

We are committed to administering these funds in a transparent manner, to constantly inform the community about the amounts mobilized and to support, through this Fund, the humanitarian efforts made by the civil society in Făgăraș Country and other areas of Romania, Moldova, and Ukraine.

Through the **Emergency Fund for Ukraine** - we want to address the urgent and medium-long term needs of the people fleeing the war in Ukraine, that can be related to their housing situation, their need for food, medical, psychological, educational or legal services, their needs related to transport, their safety, as well as guidance of migrants for the employment, as well as the educational opportunities and integration of Ukrainian children and adolescents.

**Făgăraș Country Community Foundation will support these needs by providing non-reimbursable grants to non-governmental organizations involved in these efforts.**

### **Procedure for mobilizing funds**

Făgăraș Country Community Foundation manages the joint efforts to mobilize sponsorship and donations, by making available a transparent platform for raising resources and allocating grants.

The amounts mobilized through this Fund will be directed to non-governmental organisations that support Ukrainian migrants in various forms, in the short, medium and/or long term.

**Făgăraș Country Community Foundation will finance these organizations by offering a grant (non-reimbursable financing), according to the operating standards of the Community Foundations in Romania and the FCTF granting procedure.**

**FCTF will withhold from the amount of individual donations on the euplatesc.ro platform only bank fees.**

FCTF will conclude sponsorship contracts with legal entities wishing to contribute to the Emergency Fund Ukraine, while benefiting from tax deductions regulated by the Sponsorship Law no. 32/1994. FCTF will direct a minimum of 3% of the sponsored amount to cover the bank and operational fees related to the administration of the sponsorship.

### **Grantmaking procedure**

FCTF will conclude financing contracts with partner NGOs, contracts that comply with the operating standards of community foundations in Romania, as well as the standard procedure for awarding grants specific to the Făgăraș Country Community Foundation.

*The fund is a flexible one, built to cover funding for a wide range of services, from transporting people and equipping shelters for migrants in transit, to integration, educational services or psychological counseling and many more.*

In order to access funding, FCTF will periodically invite active NGOs to access the funds mobilized by filling in a grant application detailing:

- **Short description of the NGO wishing to access funding;**
- **Name and contact details of the project/activity coordinators;**
- **The type of effort that the NGO will make in this campaign (the specifics of the activity);**
- **Who are the direct beneficiaries;**
- **Duration;**
- **The project budget and the structure by budget categories for the requested funding.**

**The eligible expenses** that an organisation may claim must be directly related to addressing the identified needs of migrants. A maximum of 10% may go towards supporting the administrative costs of the organisation.

Such administrative expenditure may include:

- compensation of an employee,
- the provision of food and the transport of volunteers,
- accounting payments, etc.

**The budget for the first round of funding is 35,000 lei.**

The financing decision will be taken by a selection committee. The committee will be made of up to 5 people from the local community, of which at least one member represents the Făgăraș Country Community Foundation.

**The selection criteria of the proposals are:**

- Proposed impact and relevance of proposed activities in relation to the needs of migrants from Ukraine;
- *experience* of the working organization with the beneficiaries;
- *expertise* related to the activity proposed in the project;
- *efficiency* of the organization in the implementation of the project;
- *feasibility* of the project and implementation time;
- Number and type of *beneficiaries*.

The funded project will be monitored by FCTF and the beneficiary organization will submit a *report* at the end of the intervention consisting of a short narrative description of the intervention and a summary of the expenses incurred.

Supporting financial documents will be sent scanned alongside the report, along with photos from the activities.
